<u>F-3</u> Helmet purchase for Driver/Engineer Tara Bosch – Action Item (Bittle)

Chief Bittle will inform the Board that D/E Bosch is very close to fulfilling the final steps to the Master Firefighter Program and he would like to reward her with a Phenix Leather helmet at the cost of \$1,379.25. Chief Bittle provided a quote for the Board's review.

<u>**F-4</u>** Mandated Overtime for Driver's – *Informational Item* (*Bittle*)</u>

Chief Bittle will explain that in that last couple of months the District has had to mandate shifts that have not be filled by a Shift Volunteer or Reserve Driver. Chief Bittle would like to change the policy to state that if an employee is mandated for an extra shift – that employee should get overtime. Staff inquired to the Fire District's FSLA Attorney Meredith McDonald who stated that under our current agreement with the Driver's – they are not eligible for overtime until they have "actually" worked more than 212 hours in a 28-day period (a copy of her email is enclosed).
