# MINUTES OF THE BOARD OF DIRECTORS OF STRATMOOR HILLS FIRE PROTECTION DISTRICT

The regular monthly meeting of the Board of Directors for the Stratmoor Hills Fire Protection District was held pursuant to notice at 3:00 p.m. on January 18, 2023

Board Members present: President Robert Colgrove, Vice-President James Pesicka, Secretary/Treasurer John Willcox, Director Cindy Dent, and Director Richard Dull. District Personnel present: Fire Chief Shawn Bittle and Administrative Chief Dottie Barrett.

## **Approval of Previous Board Meeting Minutes**

It was moved and seconded (Pesicka/Willcox) to approve the Board meeting minutes for December 7, 2022. The motion passed unanimously with all Directors voting.

## Fire Chief Report -

- December Calls per District
  - o The Fire department ended 2022 at 2332 calls for service that is one (1) call less than 2021 of 2333.
- Status reports
  - o Chiefs' notes -
    - The Fire Chief of Security Fire Department has requested to remove his crews from the Fire Station – they would continue to run calls with our crews, they just want to remove them from our building. Discussion took place and the Board of Directors expressed their desire to keep the crews here. Chief stated he would relay that message to Chief Girardin.
  - o Apparatus (responsibility assigned to D/E Patalano)
    - Engine 414 still has an exhaust pipe that needs to be fixed the mechanic ordered the wrong pipe and is currently awaiting for the correct pipe.
    - Engine 410 is still awaiting the new roll-up door.
  - o Training (responsibility assigned to Chief Bittle)
    - February's training will be Objective training with a mass exercise on Saturday, February 11, 2023. The crews will do shift trainings that will eventually be used on the Saturday training.

- o Inspections (responsibility assigned to Mark Stanwood)
- o Recruiting (responsibility assigned to Chief Bittle)
  - The Driver David W. Nelson Memorial Fire Academy will start February 1<sup>st</sup> with approximately 12-13 students.

# 2023 Official Meeting place/time and Posting Places

Chief Barrett informed the Board that they need to set the official meeting place/time and posting places for notices of district meetings for 2023. It was moved and seconded (Pesicka/Willcox) to approve the designation of the location, dates and time of the 2023 regular Board Meetings at the Stratmoor Hills Fire Department, 2160 B Street in El Paso County on the third Wednesday of each month at 3:00 p.m. except for the December meeting which will be held on December 6, 2023, at 3:00 p.m. The annual Budget Workshop will be on October 11, 2023. All required District notices will be prominently posted at the Stratmoor Hills Fire Department, the Stratmoor Hills Water District office at 1811 B Street and the Stratmoor Hills Elementary School at 200 Loomis Avenue and the Fire District's Website. The motion passed unanimously with all Directors voting.

# Approval of Resolution No. 2023-01

Chief Barrett informed the Board that they must appoint a Designated Election Official (DEO) for the May 2023 Board of Directors Election. At this time staff is recommending Dorothy R. (Dottie) Barrett be appointed the DEO. It was moved and seconded by (Pesicka/Willcox) to adopt Resolution No. 2023-01 to appoint Dorothy R. (Dottie) Barrett as the Designated Election Official (DOE) for the May 2, 2023, Election. The motion passed unanimously with all Directors voting.

## Approval of Resolution No. 2023-02

Chief Barrett informed the Board that the Directors must adopt Resolution No. 2023-02 to conduct the regular election of the eligible electors of the District to be held on May 2, 2023, between the hours of 7:00 A.M. and 7:00 P.M. in accordance with Uniform Election Code. At the time, three (3) Directors will be elected to serve a four-year (4) term. It was moved and seconded (Pesicka/Willcox) to adopt Resolution No. 2023-02 to conduct a Board of Directors Election on May 2, 2023, to elect three (3) Directors that will serve a four-year (4) term for the Stratmoor Hills Fire Protection District. The motion passed unanimously with all Directors voting.

# **CE-1 Career Employee Working Conditions Policy Update**

Chief Bittle informed the Board at the December meeting that he has clarified the wording in the Shift Swap section and is requesting this policy update to be approved on the second and final reading. It was moved and seconded (Pesicka/Willcox) to approve the CE-1 Career Employee Working Conditions Policy Update on the second and final reading. The motion passed unanimously with all Directors voting.
