New District Manager Ready to Return to Former Position

He's only been gone for 3 1/2 years, but it appears that former District Manager, Kirk Medina, is ready to return to Stratmoor Hills. The Board of Directors announced at their Regular Meeting on August 16th, that Mr. Medina had been selected after a recent search process. Named as the sole Finalist for the position in July, Kirk was interviewed in early August. He accepted the offer that was presented to him after that interview and the Board approved his Employment Agreement during that August 16th meeting

Mr. Medina first came to the Districts in 2015 after serving as Utilities Operations Manager for the City of North Las Vegas for over 15 years. He served Stratmoor Hills until the end of 2019, opting to accept a similar position in Oregon working for the Pacific City Joint Water & Sanitary Authority. Family brought him back to Colorado in 2021 and he has recently been serving as Manager of the Fountain Mutual Irrigation Company before being selected to return to Stratmoor Hills.

Kirk brings with him 20+ years of management experience in the water/wastewater field. While currently certified in Water Treatment Systems and Water Distribution Systems in the State of Oregon, he intends to seek reciprocity and renew his licenses in Colorado. Mr. Medina also brings with him a Bachelor's in Business Administration and a Master's in Public Administrator.

Mr. Medina considers his former tenure with Stratmoor Hills to be one of the highlights of his career. One accomplishment he is proud of was securing the funding for the construction of the District's new Water Treatment Plant as well as obtaining grant funds to cover all the cost of design and engineering. He'll now get to see the fruits of his labor as the Plant has been up and running successfully since the middle part of 2022.

Kirk will assume the duties as District Manager on September 6th and current Interim District Manager, Steve Rabe, will depart for the third time after providing some in-office orientation.

SAFETY WARNINGS for DRIVING / RIDING IN CAR:

Sitting too close to the steering wheel is dangerous – may be life threatening. If the air bag deploys it can give you a bruise, break collar bone or cause serious burn injuries.

Having loose "stuff" in your car is DANGEROUS. In the event of a crash or rollover this "stuff" can hurt you - maybe severely.

Ensure you and your passengers are always wearing seatbelt properly because it is a proven fact that those individuals not seat belted in can become projectiles during a rollover accident.

If you use your mobile phone while driving use a "hands free" device will reduce distractions and allow you to focus on the traffic.

Never wear headphones or an ear plug while driving and try to avoid distractions such as changing out CD's, going through wallet or purse etc.

IF YOU SEE EMERGENCY VEHICLES BEHIND YOU:

If you see an Ambulance, Fire Truck or Police Officer with lights and/or sirens on, please safely pull over to the right side of the road.

DO NOT PULL OUT INTO AN INTERSECTION – they will find a way to go around you so that everyone is safe as they do not want to cause another emergency.

THE FIREFIGHTERS CANNOT:

We cannot re-light your pilot light on your stove, water heater or furnace.

We cannot turn your gas back on once it has been turned off.

We cannot make any repairs or verify any repairs are correct and in proper working condition.

We cannot pump water out of basements or crawl spaces; however we can try to turn your water off in the event of a broken water line.

We do not certify Fire Extinguishers – you can find a company in the yellow pages.

We do not fill swimming pools

We have no control over your neighbor's weeds, trash, or junk – Please call

We cannot cut down dead trees or clear bushes along creek beds or ravines.

While on occasion we will come rescue a cat in a tree, however we will not risk the Firefighter's safety if we cannot reach the animal. Please call the Humane Society for help.
